3) To appoint Shri Nitin Shukla (DIN:00041433) as an Independent Director of the Company w.e.f. 24th March, 2022 for a term of five (05) consecutive years i.e. upto 23rd March, 2027, not liable to retire by rotation.

The Board of Directors has approved appointment of Mr. Niraj Trivedi, Practicing Company Secretary to act as Scrutinizer for conducting Postal Ballot process including scrutinizing the Remote E-voting process to be provided to the Shareholders to cast their votes on the Resolutions proposed in the Postal Ballot Notice.
